An Update On Our Ban Box Shifting Campaign

Since our last update, we have continued to gather support for the Ban Box Shifting campaign. Most recently, Sian Berry, London Assembly Member, put forward a <u>motion</u> to the London Assembly regarding banning box shifting. This motion passed 13-7. More specifically, this means the London Assembly is urging the Chair of the Assembly and the Mayor to write to the Department for Levelling Up, Housing and Communities to support the demands of the Ban Box Shifting campaign. This is a positive step and shows signs that we are shifting beyond campaigning and into reform.

We are continuing to collect signatures from councillors and MPs across England for Ban Box Shifting's Open Letter to Government. As we come into winter, we begin to notice the effects of box shifting on our high streets and in our communities even more. It is our hope that by continuing to gather support and creating more noise for the campaign we can make an even stronger case for legislative change.
